**Course Objective:** The survey course in US history is designed to provide the student with the basic knowledge and understanding of present institutions through the study of their past development. This course should also give the student a better understanding of germane disciplines such as political science, sociology, philosophy, literature, and economics in addition to preparing the student for careers in teaching, law, and public service.

**Examinations:** During the course of the semester there will be three unit exams plus the final exam. The format for the unit exams will consist of matching/identification, content essays, and one interpretive essay. The format for the final exam will be multiple choice and is a modified comprehensive exam. An examination booklet (bluebook) will be required for each unit exam and a Scantron Answer form (green) will be required for the final exam.

**Examination make-up policy:** Remember that making up an exam is a privilege and NOT a right. Emergencies happen in all our lives and obviously are not anticipated but IF there are truly extenuating circumstances that prevent you from taking the exam at the scheduled time; you MUST contact me prior to the exam (documentation may be requested) to make arrangements for your make-up exam. (Please understand that having a REALLY GOOD TIME the night prior to the exam does not extenuating circumstances make.) All make-up exams are 100% essay and there is only one make-up opportunity per customer. You have one week following the missed exam to make it up.

**Grading Policy:** All examinations and papers assigned (including the final) weigh equally and count for  $\frac{1}{4}$  the course grade. Final semester grades will be based on the following averages: 90-100 = A; 80-89 = B; 70-79 = C; 60-69 = D; and below 60 = F.

**Attendance Policy:** Attendance is mandatory and along with class participation can influence your final grade. If you are absent a total of nine times from a MWF class or seven times from a TTh or MW class, your average will drop ten points. It is your responsibility to find out what you
