

CATALOG DESCRIPTION:

Topics address recently identified current events, skills, knowledge and/or attitudes and behaviors pertinent to the technology or occupation and relevant to the professional development of the student. Designed to educate individuals in all aspects of child maltreatment including procedures for observations, documentation and interpretation of policies. Utilizes outside resource persons, as well as films, lectures, etc. Includes classroom activities to encourage problem-solving and decision-making techniques for situational problems. Reviews current federal, state and local child abuse laws, including Texas licensing standards.

COURSE LEARNING OUTCOMES/PROFICIENCIES:

The Student will examine research and literature on child abuse and neglect; discuss issues relating to families and dysfunctionalism as well as outlining the rights of parents and children. The student will identify the normal development of children and how maltreatment can impede healthy development; identify characteristics of functional and dysfunctional families; recognize signs of abuse and neglect; describe ways to work effectively with abusive behaviors; and develop an understanding to the prevention efforts that are currently being made in the area of child abuse and neglect.


confuse which class the assignment is for. Each discussion question is worth 20 points. All of the discussion questions are worth 200 points in total.

- 2. Review Questions From the first two chapters, choose four of the review questions from the end of each chapter. Email me a total of 8 questions, answers, and page numbers. In other words, by 1-27, send me eight review questions from the chapters one and two. Include the answers and page numbers. Discussion questions and review questions share the same corresponding due dates. The due dates are as follows:
- a. Chapters 1-2 are due 1-27.
- b. Chapters 3-4 are due 2-3.
- c. Chapters 5-6 are due 2-15.
- d. Chapters 7-8 are due 2-25.
- e. Chapters 9-10 are due 3-8.
- f. Chapters 11-12 are due 3-21.
- g. Chapters 13-14 are due 3-31.
- h. Chapters 15-16 are due 4-11.
- i. Chapters 17-18 are due 4-21.
- j. Chapters 19 is due 5-3. Overall, this assignment is worth 300 points.
- 3. Paper Choose a topic on child abuse. Use your glossary and table of contents to help with ideas. They choose at least five resources to write a five to seven page paper. Remember to refer to your resources throughout your paper. Also, include a works cited page as well. This paper is due March 4th. This assignment is worth 100 points.
- 4. Locate a local agency that assists persons who have been abused. Share brochures and other information about how the agency helps. Write at least a one page paper about what the agency does to help and how someone can get involved with the organization. Email or mail me this assignment no later than Feb 22nd. This assignment is worth 100 points.
- 5. Find a way to help with someone who has suffered from abuse. Or, find a way to help prevent abuse. You can do so in one of several ways, choose one:
- a. Write a children's story about overcoming great obstacles
- b. List 50 specific positive things to say to a child.
- c. Come up with three scenarios of abuse. Then, write what you could do in that situation to help. Be specific about what you would say and do.
- d. Share about abuse in your life for someone's life close to you. Share what could be done now to help in dealing witht he affects of abuse.

This assignment is worth 100 points and is due no later than April 26th.

6. Final - is worth 200 points and is due April 29th. Come up with three test questions from each chapter. Write out the question, provide the answer as well as the page number(s). Email me this assignment. Early work is acceptable and appreciated.
