- Knowingly using, buying, selling, stealing or soliciting, in whole or in part, the contents of an unadministered test.
- The unauthorized transporting or removal, in whole or in part, of the contents of the unadministered test.
- Substituting for another student, or permitting another student to substitute for one's self, to take a test.
- Bribing another person to obtain an unadministered test or information about an unadministered test.

 - provide grades for major assignments within 2 weeks of the due date or at least 3 days before the next major assignment is due, whichever comes first.

Digital Protocol

Attendance Policy – Face to Face classes

Students are expected to attend class regularly. Attendance will be recorded each class period. Excessive absences will be grounds for disciplinary action, and will be determined on a case-by-case basis. If you are more than 15 minutes late to class or leave class early without notifying the instructor, this will count as an absence. Students are permitted 3 unexcused absences before a loss of a letter grade. This is important and can drop your grade significantly.

Please understand that this is a required course for the Criminal Justice program in order to prepare you for a career in the criminal justice system or to transfer to a 4 year university. Quality work and active participation is expected and not to be negotiated. As a general policy, grades will be taken in class. Any written assignments or tests will be graded outside of class. You can expect feedback on assignments within a week's time.

Grade Inquiry Policy

It is the responsibility of the individual taking this course to maintain accurate track of assignment submissions and grades. There will be opportunities during the semester to meet with the instructor to discuss your academic

1. Participation and Attendance:

Each student will be expected to participate in class discussions and be in class and on time. Over 7 unexcused absences will cause you to receive 0% for this portion of your grade. Please see above for additional attendance information.

You will be expected to bring your textbook and binder to class every day. This will count as part of your participation grade.

2. Capstone Project

There will be a group project during the semester. I will be assigning groups about a month into the semester. You will be responsible for doing a powerpoint for the project and presenting your project to the class at the end of the semester. You will be given more details on the group project and a grading rubric as the due date nears. You will choose an infamous juvenile criminal and you will trace their way through the juvenile justice system through articles, videos, and other research.

3. Exams

You will have 2 exams over the semester. You will have a midterm and a final exam. All of your exams will include multiple choice, listing, fill in the blank, short answer, and True/False questions. The final exam is comprehensive so it will cover what you have learned over the entire semester.

4. Binders* and Class Assignments

For this class you will keep a 2 inch binder. You will need a set of dividers. All class materials will be kept in the binder and the binder will be checked several times throughout the semester to make sure you are keeping them neat and all assignments are in them. You will receive a table of contents and a monthly schedule to keep in your binder. You will also be doing several in class assignments throughout the semester that will count as a grade. If you are absent, you will miss out on the assignment and will not be able to make it up.
