

- 4. Final Exam: Your final exam will be comprehensive, meaning that it will cover all the chapters we study this semester. (Chapters 1-13). The final exam will consist of multiple choice, fill in the blank, key term identification, and short answer questions. IF YOU STUDY ALL OF YOUR SEMESTER GUIDED NOTES AND YOUR ASSIGNED READINGS, THEN YOU SHOULD DO WELL ON THE FINAL EXAM.
- 5. Research Paper: Your research paper will have a cover page, a reference page, and will be 3 5 typed double spaced pages. Your cover page and reference pages DO NOT count as part of the 3 5 page requirements. You should type your paper in Times New Roman, 12 pt. font. You will have deadlines throughout the semester to help space out the writing of the research paper. Your paper topic should be consistent with the content of this class and your topic MUST be approved by me. You may find the following links helpful when beginning to right a research paper:

6. Discussion Questions: Throughout the semester, I will assign discussion questions that will gauge your knowledge of the chapter content and relevant subject matter. When you have a discussion question assigned, you will be required to post an original post answering the discussion question by Thursday of the week the question is assigned. By 11:30 p.m. on Sunday ending the week you will have to respond to at least two students with a substantial response that lends to the perpetuation of the conversation. A response to your class mate that says, "Great job." or "Good post" is not an adequate substantial response.
