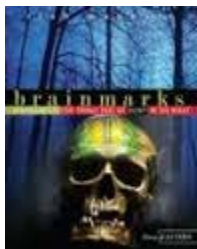
Course Description:

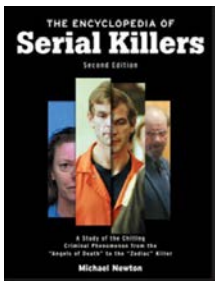

Disclaimer

This syllabus is tentative and subject to change in any part at the discretion of the instructor. Any changes will be in accordance with Odessa College policies. Students will be notified of changes, if any, in timely manner.

Original Effort

The work submitted for this course must be original work prepared by the student enrolled in this course. Efforts will be recognized and graded in terms of individual participation and in terms of ability to collaborate with other students in this course.

Description of students

Students enrolled in this course are Odessa College students who are majoring in Criminal Justice studies or those who have an interest in studying criminal justice.

Digital Protocol

Please understand that this is a required course for the Criminal Justice program in order to prepare you for a career in the criminal justice system or to transfer to a 4 year university. You can expect feedback on assignments within a week's time.

1. Participation and Attendance:

Each student will be expected to participate in class discussions and be in class and on time. Over 7 unexcused absences will cause you to receive 0% for this portion of your grade. Please see above for additional attendance information. You will be expected to bring your textbook and binder to class every day. This will count as part of your participation grade.

2. Capstone Project

There will be a group project during the semester. I will be assigning groups about a month into the semester. You will be responsible for doing a powerpoint for the project and presenting your project to the class at the end of the semester. You will be given more details on the group project and a grading rubric as the due date nears.

3. Exams

You will have 2 exams over the semester. You will have a midterm and a final exam. All of your exams will include multiple choice, listing, fill in the blank, short answer, and True/False questions. The final exam is comprehensive so it will cover what you have learned over the entire semester.

4. Binders* and Class Assignments

For this class you will keep a 2 inch binder. You will need a set of dividers. All class materials will be kept in the binder and the binder will be checked several times throughout the semester to make sure you are keeping them neat and all assignments are in them. You will receive a table of contents and a monthly schedule to keep in your binder. You will also be doing several in class assignments throughout the semester that will count as a grade. If you are absent, you will miss out on the assignment and will not be able to make it up.
