Credit Hours: 3

A developmental course that introduces elementary algebra with some arithmetic review. Includes signed numbers and rational numbers with operations through exponentiation; algebraic expressions and their operations; linear equations and inequalities including applications, graphs. The student will learn to select appropriate mathematical techniques and technologies and use skills in information organizing, processing, planning, and problem solving. Credit is not transferable. This course does not satisfy requirements for any degree plan at College. Placement testing is available. Attendance is mandatory for TASP/THEA liable students. Lab fee required. (SCANS 3, 8, 9) Prerequisite: MATH 0371 passes with a C or better or satisfactory placement score. Co requisite: 14 hours in the Math Academic Resource Lab.

Course Objectives

1.0 Performing algebraic operations with real numbers.
2.0 Solve equations and inequalities and solve applied problems.
3.0 Graph equations and inequalities.
4.0 Verify equivalent expressions and perform basic operations with polynomials.
5.0 Perform polynomial operations and factoring algebraic expressions

Materials: MyMath Lab access code, computer access and head phones

- Modularized Math is a computer assisted, competency based course in which students are able to progress at their own pace to complete the course material. The instructors are there to guide each student to mastery level. Mini break-out lecture sessions will be offered on topics that students need extra attention. Instructors will provide students with audio and video lectures and power point presentations that are embedded into their MyMath lab. Instructors will provide just-in-time assistance to students as they work in the modules.
- Mastery at the 80% level or higher is required on all module components.
- Students will challenge each module (chapter) of the course by taking a pre-module test. By showing mastery, they may progress to the next module. If they do not show mastery, they will complete their personalized homework on each unit in the module to the mastery level to continue. When a student has completed the individual unit work, he/she will take the post-module test. The same process will be followed for each module until the student completes all the modules for the course. If a student does not meet the mastery level on the post-module test, he/she will be directed to complete problems assigned in their customized study plan of the module. After completion of this element, they will re-take the post-module test. The student will repeat this process until they show mastery on the post-module test.
- Students are required to attend the math tutoring lab at least one hour per week until they have completed the course.
- All pre and post module tests are to be taken during class time or in the math lab and are password protected. The final exam will be proctored.

Students who complete a course within the semester are able to register and start the next course remaining in their developmental sequence. If a student does not

finish a modularized course, he/she will be assigned a Z grade that will allow the student to continue the course the following long semester from the point in the course that the student had completed.

Technology:

Students must have a valid e-mail address to register for computer software. The email address that you use to register your software will be the email address to which I will send any information or announcements. Please check this account regularly. It is recommended that you use your Odessa College email address. All work is done through the internet, so you need internet access. If you do not have access to the internet, you may use the computers in the math lab.

Tuition Discounts

The "First Course is Free" discount waives standard tuition and fees for the first 3 credit hours taken at Odessa College. The discount applies to high school graduates taking their first class at Odessa College as well as transfer students taking their first class at Odessa College.

The "Academic Progress Discount" provides a 10% tuition discount upon completion of 30 credit hours until reaching 45 credit hours. It provides a 20% discount upon completion of 45 credit hours until reaching 60 credit hours. Student must maintain a 2.0 GPA to remain eligible for the discount.
