6.0	Solving quadratic equations by the technique of completing the square and using the quadratic formula and graphing quadratic equations.

All students will take the final exam in the Math Lab located in the OC Mathematics Department. The final exam is comprehensive and will

be due by 8:30 PM on December 10th. You will not be allowed to bring your cell phone into the final exam area. If you do not take the final exam, you will receive an F for the course.
