Course description: A survey ofthe political, social, economic, cultural, and intellectual history of Texasfromthe pre-Columbian era to the present. Themes that may be addressed in Texas History include: Spanish colonization and Spanish Texas; Mexican Texas; the Republic of Texas; statehood and secession; oil, industrialization, and urbanization; civilrights; and modern Texas.

Course objective: Study of the past tells us where we are, where we came from and, to a large extent, where we are going. The survey course in Texas history is designed to provide the student with the basic knowledge and understanding of the state's institutions through the study of their past development. This course should also provide the student with a better understanding of such germane disciplines as political science (especially Texas government), sociology, philosophy, literature, and economics in addition to preparing the student for careers in teaching, government service, international relations and the law.

Textbook: Calvert, et al., The History of Texas, 4th edition.

Unit One: Spanish, Mexican, and The Republic of Texas (chs. 1-4)
Unit Two: Statehood, Secession, and Reconstruction (chs. 5-8)

Unit Three: Modern Texas (chs. 9-13)

Course outcomes:

- 1. Create an argument through the use of historical evidence.
- 2. Analyze and interpret primary and secondary sources.
- 3. Analyze the effects of historical, social, political, economic, cultural, and global forces on Texas history.

Examinations: During the course of this semester there will be three unit examinations and six short quizzes. Scantron Answer Forms (882-E green) will be required for each exam. Paper for the short answer portion will be furnished. The examinations will be administered on (or about) the following dates: **TBD.** The quizzes will occur at random.

Examination make-up policy: Remember that making up a missed examination is a privilege and <u>not</u> a right! If you have to miss an exam, see me for further instructions. There are <u>no</u> make-ups for the quizzes.

Grading policy: All examinations (and project) are weighted equally and will count for 80% of the course grade. The short quizzes/assignments will count for the other 20%. The final course grade will be assigned based on the following averages: **90-100=A**, **80-89=B**, **70-79=C**, **60-69=D**, **and below 60=F**. Once a course grade is assigned, it is **final!!!** The need to retain eligibility (athletic or otherwise), keep your scholarship, please your parents, get into law school, medical school, etc., may be important reasons to change a grade, but they are not valid. **A final grade is just that—final.**

Academic dishonesty: Cheating and/or plagiarism is not be tolerated. Suspected cheating or plagiarism may result in a reexamination in a controlled environment, a failing grade, or dismissal from the course.
