$\textbf{Course Description: WLDG 1417 Introduction to Layout and Fabrication} (48.0508) (2-6) \ 4$

hours

A fundamental course in layout and fabrication related to the welding industry. Major emphasis is on structural shapes and use in construction. The student will identify welding symbols; identify and select measuring instruments and tools for fabricating projects; recognize correct layout and fabrication terminology; and identify structural shapes and materials. Tuition Discounts

The "First Course is Free" discount waives standard tuition and fees for the first 3 credit hours taken at Odessa College. The discount applies to high school graduates taking their first class at

Odessa College as well as transfer students taking their first class at Odessa College. The *"Academic Progress Discount" provide* a 10% tuition discount upon completion of 30 credit hours until reaching 45 credit hours. Dropping a Course, unexcused absences, or withdrawing from College

***WARNING—READ CAREFULLY! ***

Students wishing to drop a non-developmental course may do so online using WebAdvisor, at the Wrangler Express, or Registrar's Office.
