Course Description: WLDG 1430 Introduction to Gas Metal Arc Welding (GMAW) (48.0508) (2---6) 4 hours

A study of the principles of gas metal arc welding, setup and use of GMAW equipment, and safe use of tools/equipment. Instruction in various joint designs. The student will describe welding positions with various joint designs on plate; describe safety rules and Equipment used; describe the efforts of welding parameters in GMAW; and understand safety rules, equipment used and testing performed by visual inspection. Student will weld various types of structural material and diagnose welding problems and perform visual inspections. Lab fee required. (ICOs 1)

Tuition Discounts

The "First Course is Free" discount waives standard tuition and fees for the first 3 credit hours taken at Odessa College. The discount applies to high school graduates taking their first class at Odessa College as well as transfer students taking their first class at Odessa College. The "Academic Progress Discount" provide a 10% tuition discount upon completion of 30 credit hours until reaching 45 credit hours. It provides a 20% discount upon completion of 45 credit

hours until reaching 60 credit hours. Student must maintain a 2.0 GPA to remain eligible for the discount.
