WLDG 2435 Advanced Layout and Fabrication (48.0508) (2-6) 4 hours

A continuation of Introduction to Layout and Fabrication course covering production and fabrication advanced skills of layout tools and processes. The student will apply appropriate techniques of fabrication; design welding projects; prepare drawings and produce templates. Apply layout offsets; take offs; bills of materials; and apply mathematical concepts in the construction of projects. This is a capstone course for the Advanced Welder Level I Certificate and the Lead Welder Level II Certificate. Lab fee required. (ICOs 1, 2, 3, 4).

Tuition Discounts

The "First Course is Free" discount waives standard tuition and fees for the first 3 credit hours taken at Odessa College. The discount applies to high school graduates taking their first class at Odessa College as well as transfer students taking their first class at Odessa College. The "Academic Progress Discount" provide a 10% tuition discount upon completion of 30 credit hours until reaching 45 credit hours. It provides a 20% discount upon completion of 45 credit hours until reaching 60 credit hours. Student must maintain a 2.0 GPA to remain eligible for the discount.

Dropping a Course, unexcused absences, or withdrawing from College

***WARNING—READ CAREFULLY! ***

Students wishing to drop a non-developmental course may do so online using WebAdvisor, at the Wrangler Express, or Registrar's Office.
